

STORAGE AND DISPOSAL:

**HOW TO USE**

GENERAL INSTRUCTIONS:

Scatter the baits evenly over the soil wherever snails and slugs are to be found. Apply at a rate of 0.6g/m². This is equivalent to approximately 60 baits per square metre. Best results are achieved by application after rain, watering or during damp and humid weather when the snails and slugs are most actively seeking food, but not when rain is imminent.

PROTECTION OF WILDLIFE, FISH, CRUSTACEA AND ENVIRONMENT:

DO NOT contaminate streams, rivers or waterways with the product or used containers.

PROTECTION OF DOMESTIC ANIMALS AND LIVESTOCK:

Keep away from animals, poultry, ducks and domestic pets as accidental poisoning may be fatal. Keep away from dogs. Dogs find this bait attractive and it may kill them. If pets are poisoned, contact a veterinary surgeon.
